

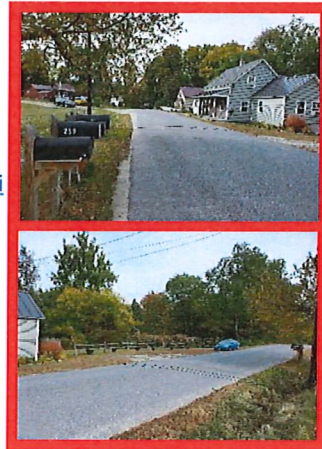

**NOTES:**

(1) ADT is the unadjusted, average number of vehicles passing in both directions at a specified location of a roadway.

(2) AADT is the average traffic volume in both directions on a section of road, adjusted for seasonal variation. Adjustment factors are released by VTrans a few months after the calendar year finishes. AADTs will then be calculated in late spring 2021.

(3) Passenger vehicles includes motorcycles, passenger cars, pickup trucks and SUVs (FHWA Veh. Classes 1-3)

(4) Single-unit trucks includes school buses, 2-axle, 3-axle and 4-axle trucks (FHWA 4-7)

(5) Tractor-trailer truck includes heavy-duty vehicles with more than four axles (FHWA 8-13)

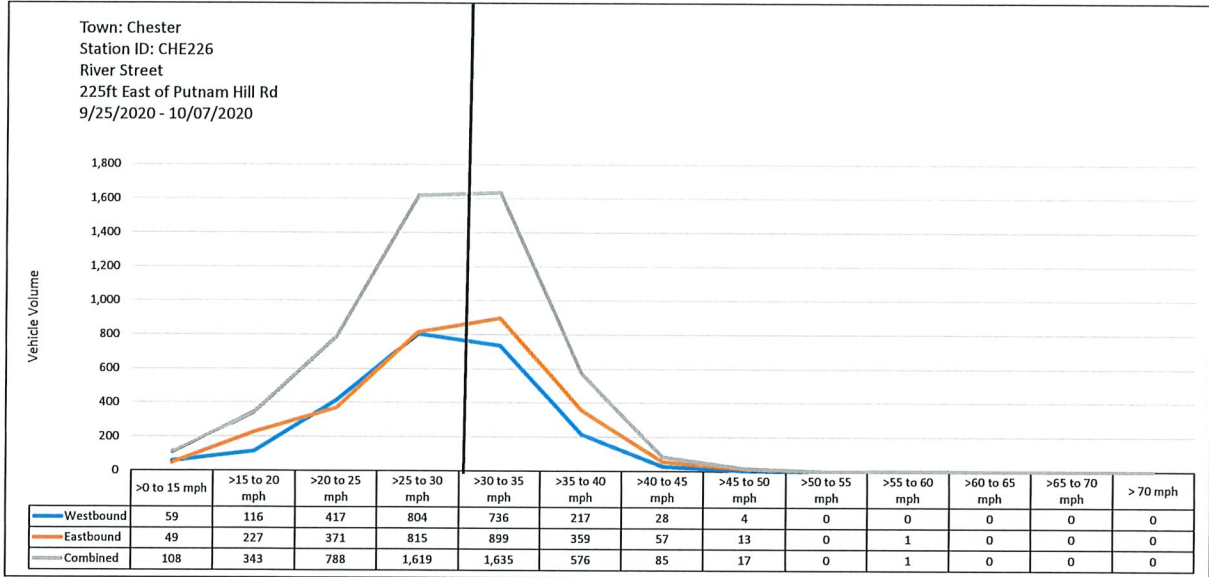
