A13	To the left of the Yosemite firehouse, toward the property line.	Tree is in fair condition and has been damaged by flooding.
A14	To the left of the Yosemite firehouse, toward the property line.	Tree is in poor condition and is dropping upper branches.
A15	Behind Town Hall. near the handicap ramp.	Tree is in fair condition and is leaning over parking lot and handicap ramp entrance to Town Hall
